Pollination practices establish new pollinator habitat, manage/improve existing habitat, and increase healthy pollinator populations.

Purpose:

Maintaining healthy pollinator communities and thriving pollinator habitats can improve water quality, provide habitat for other wildlife, and help stabilize and build soil structure. Healthy pollinator communities will be able to provide the service that they offer to crops that depend on them to produce fruits, vegetables, and nuts.

Policies for Program:

- Applicant must be a District Cooperator. ("Conservation Agreement" forms are available upon request)
- Program is available to landowner and/or farm operator (lessee).
- Applicant is ineligible for a practice reimbursement if he/she starts project before District approval.

- No duplication of federal or state cost-share shall be allowed.
- Property must be used as a farming operation.
- No more than two Ag. Enhancement Program applications will be accepted each year.
- Application approvals will be made based upon availability of funds and a ranking process.

Policies for Practice:

- Nucleus colonies must be purchased according to the following guidelines:
 - Nuc must be sourced from West Virginia.
 - Nuc must be pre-inspected by WVDA.
 - Nuc must be at least 5 frames.
 - Honey and pollen must be provided with the nuc.
 - Nuc must contain a new queen.
- All State and local laws must be followed while transporting honeybees.
- All State and local laws must be followed while operating an apiary. Such laws would include but are not limited to registration and inspection of hives.
- Cooperators must follow all WVDA best management practices on his/her apiary.
- A beginning or advanced beekeeping course must have been completed (in past 10 years) and/or cooperator is a member of a local beekeeping organization.

Practice Specifications:

- State Conservation Committee approved standards and specifications will be followed.
- If approved, *Nucleus Colonies* must be purchased no later than **June 01, 2026**.

Reimbursement Process:

- A payment will be approved as: 1. Receipts are received; 2. Verification form is signed: 3. District approves the
- All receipts and forms are due to the Monongahela Conservation District Office by June 01, 2026 otherwise payments may be delayed or even denied.
- Requests for deadline extension may be approved on a case-by-case basis.

Application must include the following:

- 1. Conservation Agreement (if applicable)
- 2. Signed application.
- 3. Farm map with individual fields and areas identified where the practice is proposed.
- 4. Lease agreement, Producer Application Form, or USDA-FSA Annual Farm Report (if applicable).
