## **PROGRAM ELIGIBILITY RULES:**

### **LAND MUST BE A FARMING OPERATION AS DEFINED IN WV CODE 63 CSR 1**

- ☐ Land must be in the counties of Mason, Putnam or Jackson in WV.
- ☐ Land must be engaged in the production of agricultural products.
- ☐ Applicant must be a District Cooperator.
- ☐ Applicant must submit IRS Form W-9 with application to be considered for the program.
- ☐ Farm Map denoting fields/acreages with location to install practice(s) clearly marked.
- ☐ Lease Agreement must accompany application if applicant is not the owner.
- ☐ Must provide a soil test no older than 2 years of date of application.
- ☐ If lime has been applied under our program it must wait 2 years and retest before re-applying.
- ☐ Soil Test Report must be from a certified lab, WVU is preferred.
- ☐ pH level requirement: Lime below 6.0 Frost Seeding is 5.8 or above
- ☐ NO Boundary Fence: Boundary fence must be already in place.
- ☐ Livestock must be present at least 5 months out of 12 months for division or exclusion fence practices.
- ☐ Cost share is available to operator or lessee.
- ☐ Owner of more than one farm may sign up each farm.
- ☐ Only two practices per farm with a \$5,000 cap per farm.
- ☐ Limit of two practices per farm per year.
- ☐ A tie breaker will be used if two or more applications receive the same ranking.
- ☐ Application approvals will be based on availability of funds and ranking.
- ☐ All practices must be complete, inspected and required invoices submitted with a signed Cost Verification Form by May 31<sup>st</sup>.

## **PRACTICE SPECIFICATIONS:**

- The practice shall be performed according to the USDA Natural Resources Conservation Service Field Office Technical Guide (WV) standards and specifications or other approved standards in effect at the time the practices are implemented.
- Job Sheets will be provided to you with your agreement.
- No duplication of federal or state cost-share shall be allowed.
- The practice shall be maintained properly for the lifespan of the longest-lived practice under agreement.
- Payment will be made only after paid invoices are received, practice is verified complete, inspected and the cooperator signs the cost verification form by May 31<sup>st</sup>.
- An IRS Form 1099 will be provided to you by the Western Conservation District for tax purposes.
