## Weed Wiper

This Lease Agreement is entered into by and between: the Northern Panhandle Conservation District AND

This Lease Agreement covers the rental of the Weed Wiper **on the terms provided below:**

### Terms of Lease:

Rental fee is: \$35/day. Charges are for actual days of use and not for pickup and return days. Lessees will not be charged for weather related delays. If equipment is kept for an unreasonable length of time, lessee will be billed at the rate of \$50 per day for the extra days.

All lessees must be a District Cooperator to be eligible to rent District equipment. **All lessees must use a surfactant to help the herbicide stick to the weeds.**

The lessee is responsible for picking up the equipment, and as requested by the District Office, to **return equipment to the USDA Service Center, or to designated location for inspection.**

The lessee is responsible for **inspecting for damages** before and after use, and notifying the District Office or your local supervisor immediately upon discovery of damage. Do not use equipment if it is damaged. **Contact information for each supervisor is located on page two of lease agreement.**

The equipment will be used only on land in the Northern Panhandle CD, unless permission is granted in writing from the District Board.

The lessee assumes all liability concerning machine while machine is in lessee's possession, including personal liability for injury incurred while machine is in operation. This liability shall be not only limited to use in the field, but includes both transportation to and from the field, to include over the highway, etc.

The lessee is responsible for any damage incurred to the Weed Wiper during miss-use or that is not the result of normal wear and tear, and will pay for any required repairs. The determination as to fair wear and tear or miss-use shall be made by a District representative.

Upon completion of work, lessee must clean equipment. **Failure to do so will result in a service charge of \$50.00 as determined by the District Board. Farm to Farm moves must be authorized by the Northern Panhandle Conservation District Office.**
