MEETING MINUTES
October 14, 2025

JW See seconded the motion. Motion carried. Youth Supervisors – Layla Shreve: members attended the first Northeastern Region FFA meeting. Ike Jones was elected as the Mineral/Hampshire Vice President and Layla was elected as Vice President At Large. 3 teams competed at the Fall Career Development Events: Livestock Judging (4th place), Nursery Landscape (5th place), and Forestry (8th place). There was an October chapter meeting. Ham bacon slaughters and processing have begun. Fruit, nut, and cheesecake sales have begun. Members plan to attend the regional meeting this Thursday at Jefferson. Seven seniors will be attending the National FFA Convention. 4-H members attending National 4-H Conference or Congress attended a Delegate Day in Morgantown. The Hampshire/Mineral Horticulture Team (Kade Suddath, Kenley Iser, Layla Shreve) attended the National Junior Horticulture Association Conference the past weekend to compete. In the 4-H division, Layla placed 9th, Kade placed 11th, and Kenley placed 15th. The team placed 5th. The State Display and Presentation won first place, and WV also won the NJHA Spirit Stick. Layla is also part of a "Flat Farmer" project with a school in Iowa to help students learn about agriculture across the Nation. She would appreciate a group picture to share following the meeting.

Kade Suddath: members participated in Fall Career Development Events: Poultry and Meats. Hampshire County hosted the first Northeastern Regional meeting where 2 members were elected to regional office: Grandin Lewis as President and Kade Suddath as Treasurer. The first chapter meeting was held and butchering of ham bacon hogs has started. 24 members attended the fall Leadership Conference. Members participated in the Hampshire High School Homecoming Parade. Members plan to attend the next regional meeting, host the Halloween country style celebration, and send 15 members to National FFA Convention & Expo. Currently, Hampshire County has 10 4-H clubs and expects to have 400 members. 2 teams will compete at the national level this year: Horticulture and Hippology. The Horticulture competition was this past weekend and the Hippology team will compete November 7-9. Finally, the shooting sports team will begin this month and the awards banquet and officer training school will begin soon.
